 - **New customers** requesting credit must establish a six month payment history to receive credit terms. and submit a credit application.
 - For both in state and out of state customers we need a copy of your state license.
 - When placing large orders, please fax to **520-325-9429** or email to balect@aol.com to ensure accurate shipping. On each order please include company name, phone number, address, and name of person placing order. You may also download our order form from our website - www.balloonsetcaz.com
 - All shipping is done through UPS. Freight charges are based on location, weight, and size of the boxes.
 - Freight costs are F.O.B. Tucson, AZ. Item prices are subject to change without notice, and quantities may be limited.

Policies regarding the return of defective products are as follows:

1. **ALL defective products** must be returned within 7 days of purchase. You will receive replacements for all defective products.
 2. **Latex balloons** should be returned in the original bag, with notation of defect and any of the unused products.
 3. **ALL foil balloons** must be deflated. Balloons that have been cut or popped will not be eligible and will be discarded.
 4. **Any foil balloons** that have been tied above the valve, used for display, shopworn or misused, or not purchased from Balloons Etc. will not be eligible for credit.
 5. **Returns Only - no defect:** If you purchase product at the discounted rate for business or Wholesale, we will NOT accept returns. Retail has 7 days w/ receipt.
